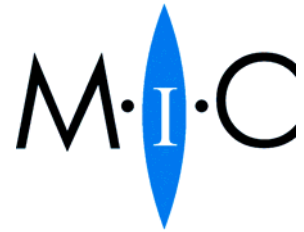

## Information note for donors

Since July 1st, 2002, management of the International Ceramics Museum in Faenza has been entrusted by the Municipality of Faenza to the M.I.C (International Ceramics Museum) Foundation (decision by the Town Council No. 270 of June 21, 2002)

According to Art. 3 of the service contract between the Municipality of Faenza and the MIC Foundation, the collections of the museum (subject to current laws on the protection of items of archaeological, artistic, numismatic, historic and bibliographic interest) are assigned to the custody of the Foundation.

According to Art. 2 of its new Articles of Association, the MIC Foundation has the following purposes:

- Safeguarding, promoting and giving value to the cultural and historical heritage of ceramic art, both in Italy and internationally
- Managing the International Ceramics Museum in Faenza on concession
- Carrying out and developing every kind of cultural activity which may be useful to give value to such historic and artistic heritage, including the organization of initiatives involving education and training, research and restoration in the field of ceramics, and public information through suitable publishing activities
- Developing activities to promote culture and art, also with public and private partnerships
- Promoting the interest of the private economic sphere, also through specific cultural, museum and exhibition initiatives
- Searching for resources to be assigned to direct acquisitions and to increase and enrich the collections, in a dynamic concept of museum, also in terms of an increase in assets
- Enhance synergies between the historic ceramic tradition of Faenza and today's manufacturing potential

Art. 6 of the Articles of Association of the Foundation establishes that donations or wills in favour of the Foundation must become part of its Management Fund and that the revenue and resources making up such a Fund must be used for the operation of the Foundation and the implementation of its purposes.

Art. 16 of the same Articles of Association lays down that, in case of winding up of the Foundation, its assets will fall to the Municipality of Faenza in order to achieve the cultural purposes of the International Ceramics Museum in Faenza .
